by signing below, I agree to the following terms and conditions.

- Each rental is for up to an 8-hour period on the agreed upon rental day.
- I am solely responsible for ensuring the boards/bags/score towers are used only in the intended manner. The games are intended to be played in a reasonable and respectful manner according to the instructions provided with the games. The games are not to be misused in a manner which could cause damage, which includes; climbing on the boards, attaching things to the boards/bags/towers, resting drinks on the boards/bags, etc. It is the responsibility of the renter to assure that misuse does not occur.
- Renter is responsible for inspecting boards/bags/towers at delivery time for any existing issues.
- Boards can be used on Concrete, Grass, or older paved parking lots. They cannot be used on any recently sealed or painted lots as it will ruin the bags.
- Boards/Bags/Towers must be returned in the same condition as delivered and report any damage at Return time.
- The replacement costs for damaged/lost goods at Return Time are as follows (renter does not get to keep damaged equipment):
 - Board \$300 (must be replaced in a set)
 - o Bags \$25 Each
 - In addition, the renter will be responsible for any lost revenue from future rentals due to broken/missing equipment.
- Items must be picked up in Massena NY and returned to Massena NY in the provided bags.
 - o If you need delivery within 5 miles of Massena NY, cost is \$25 (waived at 5+ sets)
 - o If you need delivery within 45 miles of Massena NY, cost is \$75 (reduced to \$50 at 5+ sets)
- Limit of Liability NNY Cornhole and all representatives are only financially responsible and liable for up to but not to exceed the payments and security deposit received by the renter, for the rental price of the games during the rental period agreed upon. The renter acknowledges that they are solely responsible for assuring that their guests are using the lawn games in a safe and civil manner. The renter agrees that any and all bodily injuries sustained, up to and including death, are the responsibility of the renter and their guests. The renter and guests indemnify and hold harmless NNY Cornhole and all representatives involved from any and all legal action.
- NNY Cornhole will do its best to ensure that all equipment is available for the agreed upon rental time. However, if
 equipment is not available due to theft, damage from a previous rental, delayed return from a previous rental, etc...
 NNY Cornhole will work with the renter to offer a refund for the missing equipment if we cannot offer an alternative
 option.
- Inclement Weather In the event of inclement weather during the rental period it is the responsibility of the renter to move the rented equipment to a dry location to protect them from sustaining water or weather damage.
